INDIVIDUAL HOUSING LOAN SCHEME CONVERSION OF HOUSING LOAN AVAILED UNDER COMMERCIAL TERMS

TEXT OF THE CIRCULAR NO. 44 DATED 22ND FEBRUARY 2012

"Individual Housing Loan Scheme (IHLS) for staff members was revised in terms of Circular No.CDO/P&HRD-IR/64/2007-08 dated 5th February 2008. Among other revisions, one of the provisions pertains to conversion of then existing commercial loans availed from verifiable sources for the purpose of housing at concessional rate of interest. Such conversions had to be effected upto end of September 2008.

Subsequently, in terms of Circular No.CDO/P&HRD-IR/32/2008-09 dated 25.06.2008 it was decided to permit the conversion of commercial loan for housing to IHLS without any restriction of time i.e. our members can as of date convert their commercial loan at concessional rate of interest.

Quite a large number of our staff have not completed the stipulated service of 5 years to avail of the Individual Housing Loan but availed of the Housing Loan at commercial rate of interest. These employees continue to pay higher rate of interest even if they are now eligible to avail IHLS.

The Federation had taken up this matter with Corporate Centre and we are pleased to inform members that instructions in this regard are being issued permitting our Staff members who have availed commercial loan from the Bank for the purpose of housing, irrespective of time frame, will now be eligible to apply for Individual Housing Loan at concessional rate of interest on completion of minimum number of years of service to avail loan under Individual Housing Loan Scheme.

In future too, our employees if avail commercial loan will be permitted to convert it into loan at concessional rate of interest on completion of 5 years of service".
