NOTICE

36TH GENERAL COUNCIL MEETING

In terms of Bye-law No.19 of our Union and pursuant to the decision of the Central Committee, NOTICE is hereby given for the **36th** General Council Meeting to be held on **11th and 12th June 2016** at Kalaignar Arangam, Anna Arivalayam, Teynampet, Chennai. The exact time of commencement of the Council will be advised in due course.

In terms of Bye-law No.16, the General Council shall transact the following business:

- a) To adopt General Secretary's Report and Statement of Accounts of the Union for the years ended **2012, 2013, 2014 and 2015**.
- b) To elect Office-Bearers.
- c) To consider amendments to Bye-laws and other propositions given notice of by units and recommended by the Central Committee and those proposed by the Central Committee.
- d) To transact such other business as may be approved by the Central Committee of which notice has been given in the Circular convening the meeting
and
- e) To consider other business that may be brought forward with the permission of the Chair.

UNIT ELECTION

In terms of Rule 5(ii) of the Bye-laws of our Union the last date for the elections to Unit Committees and to the posts of Delegates to the General Council as laid down in Bye-law No.14, Rule 3 (vi) and (vii) will be 13/05/2016 as notified earlier vide our **Circular No.104** dated 29.04.2016. All Unit Secretaries are therefore requested to send the name(s) of Delegate(s) to the General Council so as to reach the Headquarters not later than 18/05/2016.

ASSISTANT GENERAL SECRETARIES (23)

The list of Units grouped under various Zones has been despatched by separate post. Only Members from the Units falling under the respective Zones shall be eligible to file nominations.

All nominations for the above-mentioned posts should be sent in sealed covers superscribed 'Nominations for Office Bearers'.

Note: In pursuance of the decision taken by the Central Committee at its meeting held on **15.04.2016**, to continue with the existing positions in the Central Committee as per the provisions of the Bye-laws, Zones under each Sub-office are furnished hereunder :

Coimbatore Sub-Office	Zones XVI to XX
Madurai Sub-Office	Zones XI to XV & Zone XXI
Tiruchirapalli Sub-Office	Zones VII to X & Zone XXIII

WITHDRAWALS :

The last date for withdrawal of nominations is **25/05/2016**.

ELECTION : RULES REGARDING FILING NOMINATIONS AND DISQUALIFICATION:

In terms of Bye-law No.40 of our Union each candidate should be proposed and seconded by one Delegate/General Council Member each from two different Units of the Union and no Delegate/General Council Member shall propose or second one and the same Member for different posts in the organisational elections and no Member shall contest for more than one post in the organisational elections though he might have been duly proposed and seconded for more than one post.

If a contesting candidate who had been duly proposed and seconded for more than one post does not withdraw all the other nominations except one, in time, all his nominations shall be treated as invalid.

In terms of Rule 6 (i) & (ii) of our Bye-laws, Members whose action attracts any of the clauses under Bye-law No.7 and/or who fail to pay the levy/subscriptions in the normal course as and when called upon by the Union shall not be eligible to vote and/or contest and/or propose or second a nomination in any organisational election.
