TEXT OF THE NCBE CIRCULAR NO.8 DATED 16TH NOVEMBER 2016:

"A Meeting of the Central Committee of NCBE, under the Chairmanship of Com. Vinil Saxena, President of our organisation, was held on the 13th November 2016 at Indore, to consider the suggestions received from Affiliates/Units/Members and to formulate/finalise the Charter of Demands for 11th Bipartite Wage Settlement and also to discuss and decide on other issues relating to the organisation as per the Agenda.

Com.Sanjeev K.Bandlish, General Secretary, informed the house that Com.Chander Mohan Bhambri has been co-opted as Treasurer and Com.Ashok K. Atwal as Asstt.Treasurer, as per the authority given in the last Central Committee Meeting held at Hyderabad, which was approved unanimously by the house.

The proposal of Com.Sanjeev K. Bandlish, General Secretary for creation of more positions in the National Executive/Central Committee of the organisation on account of the proposed merger of Associate Banks of SBI with State Bank of India, which might result in creation of additional Administrative Circles of SBI and also to take care of the needs of other unions operating in the Banking Industry seeking affiliation to NCBE, was unanimously approved by the House. Further, the proposal of General Secretary to authorise him to create and Co-opt the positions in the National Executive/Central Committee in consultation with the President as and when warranted and place the same for ratification in the next Central Committee Meeting, was also approved unanimously by the House.

Thereafter, to the interim vacancies that have arisen since the last Central Committee Meeting, the undernoted co-options to the National Executive and Central Committee positions as mentioned against their names, as proposed by the General Secretary, were approved unanimously by the House:

Finally, with regard to the queries raised and suggestions given by the members on various issues pending before the IBA, viz.Medical Insurance, Compassionate Appointments, pension related issues etc., the General Secretary replied in detail and the meeting concluded with vote of thanks to the Chair."
