HON'BLE MADRAS HIGH COURT PRAISE FOR OUR UNION

After the years of legal wrangling, Shri S.Viswanathan of Sowcarpet Branch got his final shot in the W.P.No.14686 of 2003 filed by him under Art.226 of the Constitution of India to quash the circulars issued by the Bank in connection with Career Progression Scheme. Extracts from the Order of the Hon'ble Madras High Court are appended for the information of our Members:

"This writ petition has been filed by a disgruntled employee of State Bank of India, who neither wants to shoulder responsibilities nor would stomach the progress of others in their career, challenging the circulars dated 22.06.1999, 26.03.2003 and 27.03.2003 issued by the Management of the State Bank of India.

- 4. On a reading of above said circulars, it is obvious that the Bank Union had gracefully come to terms with the hard reality that the Banking sector cannot afford to remain in the stone age and successfully resist the I.T. Tsunami. Therefore, they took a bold decision to cooperate with the Management in making industry more customer-friendly, for that would only ensure the survival and progress of both....
- 7. **One Matheswaran**, another shirker like the petitioner, wanted to join the bandwagon and filed W.M.P No.207 of 2014 in the writ petition for impleading himself as respondent for **playing second fiddle to Viswanathan...**
- 15. In the considered opinion of this Court, the petitioner suffers from a misconceived illusion borne out of his reticence to take up additional responsibilities...

In the result, this writ petition is dismissed as being devoid of merits. The petitioner shall pay costs of Rs.5000/- to the second respondent Bank and the third respondent Union, within a period of two weeks from the date of receipt of a copy of this order. Consequently, connected miscellaneous petitioners are closed."
