## 38<sup>th</sup> GENERAL COUNCIL MEETING AND PLATINUM JUBILEE CELEBRATION AT CHENNAI

The Central Committee Meeting of our Union was held at Kodaikanal on 18<sup>th</sup> October 2021, wherein it was decided to hold the **38<sup>th</sup> General Council Meeting and Platinum Jubilee Celebrations of our Circle Union and our Federation** on 19<sup>th</sup> and 20<sup>th</sup> December 2021. Accordingly, the General Council Meeting will be held at Kalaignar Arangam, Anna Arivalayam, Teynampet, Chennai - 600018. While we shall be advising further details regarding the General Council, with a view to enable our Units to comply with the requirements of the provisions of our Byelaws, it has been decided to advise further as under:

- a. In terms of Rule 5(ii) all units are requested to hold the Unit Elections on or before 06-11-2021.
- b. All Units should conduct the Elections to Unit Committees and for the posts of Delegates to the General Council in terms of the existing Bye-laws irrespective of the date of their previous election.
- c. Units are requested to forward the names of elected Delegates so as to reach the Headquarters on or before 15-11-2021.

In terms of Bye-law No.14, the Units are required to elect one Delegate for every 50 members or a part thereof with a minimum of one Delegate for each unit who shall be the Unit Secretary. If there are two or more Delegates, the Delegate who is elected as such by the Unit Committee shall be the Unit Secretary.

Members whose action attracts any of the clause under Bye-law No.7 viz.

- a) Who has submitted his resignation in writing or who has revoked his authorisation to recover his subscription under 'Check off' facility.
- b) Who has failed to pay his subscriptions for three consecutive months and or LEVY as and when imposed.
- c) Whose conduct in the opinion of the Central Committee is contrary to the interests of the Union and who has or is likely to bring the Union into contempt or disrepute.
- d) Who has failed to attend 3 consecutive General Body Meetings of the Unit without valid reason

shall not be eligible to contest or vote and/or propose or second a nomination in any organisational elections in terms of Rule 6.

Members who have failed to pay the levy / subscription in the normal course as and when called upon by our Union shall also be not eligible to vote and/or contest and/or propose or second a nomination in any organisational elections in terms of Rule 6.

Such of those units which fail to comply with the instructions before the date specified above shall forfeit their right to send Delegates to the General Council.

We solicit the co-operation of all the Unit Secretaries in completing the above formalities well in time so that the arrangements for holding the Conference as scheduled can be made in an uninterrupted and smooth manner.
