#### **ASSISTANT GENERAL SECRETARIES (27)**

The list of Units grouped under various Zones has been despatched by separate post. Only Members from the Units falling under the respective Zones shall be eligible to file nominations.

All nominations for the above-mentioned posts should be sent in sealed covers super-scribed **Nominations for Office-Bearers'**.

Note: In pursuance of the decision taken by the Central Committee at its meeting held on 18-10-2021, the units in each Regional Business Office shall be grouped under Zones. Accordingly, Zones under each Sub-office are furnished hereunder:

#### **ELECTION: RULES REGARDING FILING NOMINATIONS AND DISQUALIFICATION:**

In terms of Bye-law No.40 of our Union each candidate should be proposed and seconded by one Delegate/General Council Member each from two different Units of the Union and no Delegate/General Council Member shall propose or second one and the same Member for different posts in the organisational elections and no Member shall contest for more than one post in the organisational elections though he might have been duly proposed and seconded for more than one post.

If a contesting candidate who had been duly proposed and seconded for more than one post does not withdraw all the other nominations except one, in time, all his nominations shall be treated as invalid.

In terms of Rule 6 (i) & (ii) of our Bye-laws, Members whose action attracts any of the clauses under Bye-law No.7 and/or who fail to pay the levy / subscriptions in the normal course as and when called upon by the Union shall not be eligible to vote and/or contest and/or propose or second a nomination in any organisational election.
