

SBSU FOUNDATION DAY – 4th August

The history of labour movement in State Bank of India is long and proud. A few senior employees of the then Imperial Bank of India led by Shri P.S. Chengalvarayan and Shri V. Ramanujam, with courage and conviction, rightly and judiciously met at the lawns of the High Court of Madras in mid 1946 to explore the possibility of forming a trade union of Imperial Bank of India employees in this part of the Country.

Our Union was formed in the year 1946. In July, at a meeting of employees of IBI held at Madras. They decided to start an Association in the name of "Imperial Bank of India Indian Staff Association". A Provisional committee consisting of 14 members with two secretaries and a treasurer was formed.

Shri. V.Ramanujam and Shri. P.V. Chengalvarayan were designated as Provisional Secretaries and were subsequently elected as Honorary Secretaries at the first General Body meeting held on 18th August 1946. The inaugural meeting was held on 4th August 1946 at St. Mary's Hall, Armenian Street, George Town, Madras.





To commemorate this day, foundation day was celebrated across the Chennai Circle in a grand manner. A special badge was designed and was worn by our comrades at all branches on 4th August.

SBSU pledge was also administered at all the branches on 4th of August. All the comrades showed their support and solidarity towards our Union.

Veteran Leaders who have served the Union with sweat and blood were honored across Chennai Circle at their respective Modules.







International Youth Day 2022: Intergenerational Solidarity: Creating a World for All Ages - is the theme for this year. International Youth Day is observed on August 12. To mark the event, the day calls upon governments, civil society, individuals, and communities worldwide to support activities at local and international levels.

HISTORY OF OUR UNION

Birth of Union : Our Union in the name of "Imperial Bank of India Indian Staff Association" was registered under Trade Unions Act 1926 on 25-09-1948

First President : Shri T S Ramanujam, M.A.L.L.B (London) was elected as President. He was a leading advocate then in the Madras High Court and was connected with various other Unions of Industrial Workers.

First Secretaries : Sarvashri P.S. Chengalvarayan and V Ramanujam were elected as Honorary Secretaries. Both of them were staff of the erstwhile Madras Local Head Office of the Bank.

HOW SUNDAY HAS BECOME A WEEKEND OFF IN INDIA?

Till the year 1890, there was no weekend off for workers in India. When India was under the British rule, the Mill workers in India had to work hard for all seven days of a week. They didn't get any holiday or any kind of leave to get rest. The British workers and Officials would go to church every Sunday and offer their prayers while there was no such tradition for the Indian Mill workers. Narayan Meghaji Lokhande, who was the leader of the Mill workers, presented a proposal of weekly holiday in front of the British. He said, "After working hard for six days, the workers should get a day to serve their country and society". He said, "Sunday is the day of the Hindu deity 'Khanboda', hence, should be declared as a Holiday". British Officials initially rejected the proposal and after a long 7 year struggle, the British Government declared Sunday as Holiday in June 10, 1890.

Narayan Meghajil Lokhande remembered as the father of the Indian labour movement. He fought for providing numerous facilities which are enjoyed by workers today. The government of India issued postal stamp in the memory of Narayan Meghaji Lokhande in year 2005
