
FEDERATION FOCUS: APEX LEVEL – ADVOCACY

Our Federation, committed to the welfare of our members and the protection of our rights, has actively addressed various issues with management in recent times. To keep our members informed, we have compiled a summary of the letters sent to Management. This ensures transparency and highlights our ongoing efforts to advocate for the interests of all members within the organisation.

- 1. ISSUANCE OF INSTRUCTIONS FOR PAYMENT OF ADDITIONAL TA/DA AND OTHER ALLOWANCES TO PERSONNEL DEPLOYED FOR ELECTION RELATED DUTIES AS PER ECI - The Election Commission of India emphasized that "In view of the difficult nature of the work performed by polling personnel, the Election Commission has directed the payment of remuneration for election duty carried out by them. In addition to remuneration, additional TA/DA and any other allowances shall be paid as per the norms by their parent department."
- 2. GRANT OF GRADUATION INCREMENTS FOR NON-SUBORDINATE EMPLOYEES (PHARMACISTS) - current eligibility is pass in 12th or equivalent diploma.
- 3. STAFF WELFARE ACTIVITIES PROPOSED UTILISATION OF ENHANCED WELFARE FUNDS - Best utilisation of enhanced funds to further benefit the

organization as a whole like Improvement of Holiday Home facilities, medical, providing sports kits, canteen facilities, scholarships, reservation in school seats etc.

- 4. EDUCATION LOAN SCHEME FOR STUDIES ABROAD SBI GLOBAL ED-VANTAGE FOR STAFF - Currently 110 % collateral to be given. An interest concession and collateral free loan is our demand.
- 5. MANPOWER PLANNING mechanism and parameters used in evaluating the staff requirements to be reassessed.
- 6. INTER-CIRCLE TRANSFER POLICY There is no provision for Inter Circle Transfer / Inter State Transfer for junior associates recruited after 2019, which is violations of the terms and conditions of the Memorandum of Settlement between State Bank of India and All India State Bank of India Staff Federation. Remove Ban and upholding the existing Settlements.
- 7. REIMBURSEMENT OF COST OF GLUCOMETER KIT & STRIPS Flexibility to allow reimbursement based on a prescription from any registered medical practitioner.
- 8. REQUEST FOR PROVISION OF PURCHASING COMPUTER/LAPTOP/I-PAD/TABLET THROUGH ONLINE PLATFORMS AND REVISION OF COMPUTER LOAN LIMITATIONS - . A tie-up with platforms like Amazon or Flipkart could further enhance this process, offering employees exclusive deals. The current stipulation of availing the Computer Loan only twice during an employee's service, with a mandatory gap of five years between loans to be reviewed.
- 9. PROVISION FOR EXERCISING INVESTMENT OPTION TO EMPLOYEES UNDER NPS - Currently, the Bank's investment pattern allocates a large portion of employees' contributions to Government securities, bonds, and money market instruments, without giving employees the option to decide in which asset class their hard-earned money should be invested. Given the above, we believe the Bank should reconsider the investment pattern of the scheme and provide employees the flexibility to select from different funds with varying levels of equity exposure based on their risk appetite and age, similar to the option extended by the Government of India to its employees.
