On 21st March 2025 one more round of conciliation meeting took place in CLC Office New Delhi, there were serious discussions on the demands, where officials of the Indian Banks' Association (IBA), Department of Financial Services (DFS), and Union Ministry of Finance were also present. Our agitational programmes and strike call have sufficiently highlighted the importance of our demand and we are hopeful that the Government would attend to the same seriously. We thank all our members for their enthusiastic response and participation in the agitational programmes which manifested our unity and determination to pursue our demands. Thus UFBU has deferred the proposed strike on March 24 and 25, 2025.

The International Women's Day was celebrated on 8th March 2025 at Coimbatore. We thank lady Comrades from Coimbatore, Tiruchirappalli, Madurai and Salem who enthusiastically participated and made the meeting a grand success.

In SBI, we have a women workforce of more than 65%. Our union has always given importance to schemes and policies that benefit women employees. We are keen on promoting safer and conducive workplace for women.

In the 12 BPS, the following schemes were extended to women comrades:

- Maternity leave can also be availed for infertility treatments.
- > Incase of delivery of more than 2 children in one delivery, Maternity Leave shall be sanctioned up to 12 months.
- Maternity leave for adoption of 2nd child.
- > Special maternity leave upto 60 days shall be granted in case of still born child.

The contributions of women to the banking sector and our trade union movement are invaluable. From the frontline of customer service to leadership roles in our organization, women have consistently demonstrated excellence, dedication, and an unyielding spirit in the face of challenges.

RECOVERY OF APPRAISER CHARGES FOR SECOND APPRAISER IN GOLD LOANS ABOVE RS.5 LAKHS

Gold ornaments pledged for gold loans are required to be assessed by at least one approved gold appraiser to determine their quality and value before sanctioning the loan. The appraisal charges are recovered from customers as per the norms prescribed for the respective circles. For high-value gold loan accounts with limits of Rs. 5 lakhs and above, the appraisal of the ornaments by two empanelled appraisers is mandatory in adherence to the bank's guidelines.

In several instances, customers availing loans of ₹5 lakhs and above are being charged twice, as both appraisers assess the ornaments separately and levy their fees individually. This results in an additional financial burden on customers. As per the Master Circular on Gold Loans under Agriculture and P-Segment, there is no specific mention regarding the collection of appraiser charges for loans above Rs. 5 lakhs. Our Federation urged Bank to issue clarification to ensure uniformity in the collection of appraiser charges across the branches and to avoid unnecessary financial strain on customers.

REQUEST FOR BEARING INCOME TAX ON PERQUISITE VALUE OF STAFF OVERDRAFT ACCOUNTS

Our Federation had requested the management to bear the Income Tax on perquisite value of interest free or concessional loans extended to staff members in our earlier letter vide FED/GS/2025/70 dated 18.01.2025 and thanked the management for acceding to our request and issuing circular in this regard.

Now our Federation requested the management to consider bearing the income tax on the perquisite value of Staff Overdraft accounts, as employees primarily utilise this facility to cover essential expenses such as education, children's marriage, and to meet margin requirements for availing staff housing loans.
