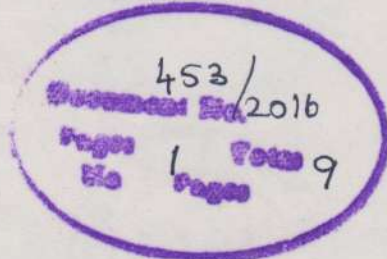

AMENDMENT TO DEED OF TRUST

This Deed of Amendment made to STATE BANKS' STAFF UNION (CHENNAI CIRCLE) SHRI V.GANESAN TRUST executed on this 09th day of November, 2016 by its General Secretary Shri D.Singaravelu.

Whereas a trust by name State Banks' Staff Union (Chennai Circle) Shri V.Ganesan Trust was brought into existence on 6th May 2004 by means of a Deed of Trust registered as Document No.225 of 2004 in the Office of Sub-Registrar, Royapuram by endowing towards the corpus fund a sum of Rs.539296 and such other sums and articles donated to the Trust by various members of State Banks' Staff Union(Chennai Circle).

Whereas in the actual working of the Trust, it is found necessary to incorporate certain changes in the Deed to make the Trust more explicit and be in accordance with the Income Tax Act, 1956.

Whereas the trustees of the said Trust by resolution passed by the Board of Trustees in the meeting held 07.10.2016 decided to make amendments to the trust deed.

NOW THIS AMENDMENT TO THE TRUST DEED WITNESSETH AS FOLLOWS:

Under the heading 'BENEFITS' new clauses 3.4 to 3.7 are added and inserted as follows:

3.4 The trust shall provide or reimburse the cost of assistive devices such as low vision aids, hearing aids with battery, wheel chair to the members with disabilities in accordance with their requirement.

3.5 The Trust shall reimburse to an extent the educational expenses for the Special Children of the members upto the primary level.

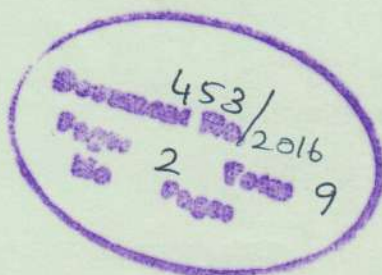
3.6 The Trust shall organize, conduct, arrange seminars, symposiums and workshops on matters relating to Trade union rights and disseminate information and advance knowledge on human rights.

3.7 The Trust shall make awareness relating to the legal remedies and provide legal aid to the members in respect of disputes/issues connected with their employment.

Under Clause 5.6 the following new clause is added and inserted:

Expenses incurred by members with disability: supported by the invoices for the materials to be purchased or the Bills.

Under the heading "GENERAL", new clauses No.8.7 to 8.11 are added and inserted which shall be read as follows:

8.7 The Trust shall be non-political and non-sectarian

8.8 Trustees shall keep or cause to be kept a minutes book of the proceedings of their meetings as well as to record all important decisions.

8.9 The Trustees will not be entitled to receive any remuneration as trustees or be interested in the supply of work or goods at the cost of the trust, but may re-imburse themselves from the trust property all expenses actually incurred by them in connection with the trust or their duties and functions relating thereto.

8.10 The income and funds of the trust will solely be utilized towards the objects of the trust and no portion of it may be utilized for payment to trustees by way of profit, dividend, interest etc.

8.11 It is hereby declared that all the other clauses as per the Deed of Trust dated 6th May 2004 shall be adopted without any change.

It is hereby declared that there is no immovable property in the name of the Trust.
